# International Travel Insurance – benefits in more detail

Our International Travel Plan policy offers you comprehensive annual travel insurance covering general travel risks whilst travelling for business and pleasure. The maximum period of time that may be spent overseas in the insured period is 183 days. The maximum length of any one overseas journey outside your principal country of residence is 95 days.

International Travel Plan can only be purchased if you have current membership of our International Health Plan Standard or Comprehensive Option. It is included within the International Health Plan Prestige Option.

International Travel Plan benefits	
1. Delayed departure	£50 for every 12 hours up to a maximum of £100
2. Cancellation or loss of deposit arising due to illness, bereavement, injury, jury service or quarantine	£5,000
3. Missed departure. Additional costs to reach destination if due to bad weather, strike or mechanical breakdown	£1,000
4. Curtailment due to illness, injury or death	£5,000
Personal possessions	
5. Loss or damage to baggage/personal effects	Up to £350 for a single item up to an overall maximum of £1,500
6. Personal money/travellers cheques if lost or stolen	Up to £250 for cash up to an overall maximum of £500
7. Passport replacement. To assist in recovery or replacement costs	£250

8. Personal accident. For loss of limbs, sight or death caused solely by an external accident	£25,000

# What are the main exclusions and limitations of International Travel Plan?

The significant and unusual exclusions or limitations are:	Where can I find more information?
Medical benefits as these are included under your International Health Plan – cover is eligible outside your principal country of residence. Your principal country of residence is the country outside the UK in which, as recorded by us, you live or intend to live for the majority of the year.	The Membership Agreement on pages 9 to 29
Unmarried children cannot remain on International Travel Plan after the renewal date following their 21st birthday (or 23rd birthday if in full-time education).	
Claims arising from an insured member’s failure to exercise all reasonable care to prevent accident, injury, illness, loss or damage.	
Sports activities listed as excluded in the membership handbook.	
Participation in sports activities as a professional	
War and terrorist risks and travel against Foreign and Commonwealth Office advice.	
Routine pregnancy and childbirth. However, we will pay for the treatment of a medical condition which arises during pregnancy subject to all other benefit limitations and exclusions on this travel policy.	
Travel against any health requirements stipulated by the carrier, their handling agents or any other public transport provider.	
Any loss or expense which is in anyway connected with an insured member’s psychiatric illness.	
Benefits 2 to 7 are subject to an excess so you will have to pay the first £50 per claim per person. Where we do not pay the first amount of any claim it cannot be claimed against any other insurance policy which the insured member may have with AXA PPP healthcare.	

Your International Travel Plan is, except as specifically provided in the membership handbook, subject to the same terms and conditions as your International Health Plan.
